APPLICATION FOR REGIONAL JOINT DEVELOPMENT ASSESSMENT PANEL APPROVAL WORKS ONLY – DECOMMISSIONING AND CAPPING OF TRONOX CELL 1 LOT 2 BANKSIA ROAD, CROOKED BROOK

Notice is hereby given that the Shire of Dardanup has received a **Development Assessment Panel (DAP) application** for the proposed capping of Tronox Cell 1 at the above address and public comments are invited.

Proposal:

Tronox Cell 1 is approximately 7.6ha in area and is a lined pond containing tailings. It contains titanium dioxide tailings-like waste that has been delivered to site as a slurry. The delivery of tailings into Tronox Cell 1 commenced in 2013 and ceased in 2021. Tronox Cell 1 has not received tailings since 2021 and is currently undergoing consolidation and drying. The next step of the process is for Tronox Cell 1 to be decommissioned and capped, this is the basis of the proposed development application.



The application comprises of two main stages summarised as follows:

- Stage 1 An earthen cap including stormwater and dust suppression management will be placed over the cell allowing settlement of the tailings planned for completion by June 2025;
- Stage 2- Following designer verified settlement of tailings after approximately 12-18 months from completion of Stage 1, final shaping of the earthen cap will occur followed by a geosynthetic cap, growing medium cover and stormwater and dust management system after which the final rehabilitation will occur, including planting and associated measures in accordance with the approved landscaping plan.
