### 8.1.1 Evacuation Reports

On 27<sup>th</sup> February 2024 there was a bushfire in Kingston. On 10<sup>th</sup> May 2024 a tornado impacted Bunbury. Both events triggered the activation of a local evacuation centre at the Eaton Recreation Centre. In both events the use of the Shire's evacuation centre was required as a result of the emergency event potentially impacting upon the Shire of Harvey's and the City of Bunbury's evacuation centres.

The Local Evacuation Support Plan was in draft. However, the content was used to guide the activations. Brief reports have been prepared on the Shire's response to the evacuations in support of the Department of Communities as per Confidential Attachment A & B.

### 8.1.2 Mitigation Activity Funding

The Shire of Dardanup has been granted \$242,350 to assist in undertaking 27 bushfire mitigation activities. Mitigation activities include mechanical treatments to reduce fuel levels, the creation of firebreaks and planned burns.

### 8.1.3 Bushfire Risk Management Coordinator

Funding Bushfire Risk Mitigation Coordinators is a Department of Fire and Emergency Services initiative to support local government in bushfire mitigation. The primary role of the Coordinator is to identify mitigation activities, per the Bushfire Risk Mitigation Plan, and seek grant funding from the Mitigation Activity Fund so as to implement those measures that receive approval.

The Shire of Dardanup has a resource sharing arrangement with the Shires of Capel and Collie for a Bushfire Risk Management Coordinator. This enables the Shire to share the expertise of that officer to contribute to protecting the community of the Shire from natural hazards.

Following a request to continue this arrangement, the Department has offered a further three year grant agreement to partially fund the coordinator role, with co-contributions from each Shire. Approval was given by Council to execute the agreement proposed by the department. We are awaiting for confirmation that the Shires of Capel and Collie have agreed to execute the agreement.

### 8.1.4 Bushfire Risk Management Plan

One of the key eligibility requirements under the MAF grants program is for the Shire to have a Bushfire Risk Management Plan (BRMP) endorsed by the Office of Bushfire Risk Management. The Shire of Dardanup's BRMP was developed in 2019 and is due for review in 2024.

The 2023 Guidelines for reviewing a BRMP were recently released and provide a clear process for the Shire to update their Plan. It is to be noted that the previous 5-year endorsement and review process has been changed to every 2 years to ensure information in the BRMP remains current and accurate.

### 8.1.5 Local Government Grant Scheme

The Shire has been granted \$230,554 through the Local Government Grant Scheme to contribute to maintaining the operational preparedness of the Shire's Bush Fire Brigades. This grant provides \$10,554 for identified plant & equipment, and a further \$220,000 for general operations.

This year's grant also included the scheduled replacement of the Burekup 1.4 appliance, and upgrade of the Dardanup Centrals 2.4 appliance to a 3.4 appliance. Due to supply chain issues the actual delivery dates are uncertain, with several other appliances still awaiting replacements from previous years.

The Shire was also seeking funding for two capital projects, to upgrade the Ferguson station and to install a bore at the Waterloo station through the Department of Fire Emergency Service Asset Maintenance Fund.

### 8.1.6 Bushfire Brigades

The most recent Bush Fire Advisory Committee meeting endorsed the Shire's Fire Prevention Order and the names of the Fire Control Officers, which has subsequently been endorsed by Council.

The Fire Control Notice has been published in the Government Gazette and will be published in a local newspaper in August. A community awareness campaign is intended to be similar to previous years.

The names of the appointed Fire Control Officers were published in the Government Gazette and South West Times in July 2024.

### 8.1.7 Committee Endorsement

The Terms of Reference (ToR) for the Local Emergency Committee encourages membership from representatives from various sectors of emergency management, Local/State Government, however, also from groups that represent communities who are <u>vulnerable</u> and have special needs.

To this end, the activities associated with Bethanie Fields Aged Care caters for a vulnerable group of people that are less physically equipped to respond to an emergency event. As such, a high degree of coordination and emergency planning is required for the organisation to be able to respond to an emerging threat. As such, acknowledging the presence of Bethanie Fields in the Shire and their role in providing an important service to the community, it is recommended that the LEMAC endorse a representative from Bethanie Fields Aged Care to be appointed on the committee as follows:

### STATE EMERGENCY MANAGEMENT DOCUMENTS

State EM Document Amendments

The State EM Policy Branch of the Department of Fire and Emergency Services (DFES) administers the review and consultation of the State emergency management documents in consultation with relevant stakeholders.

To maintain accuracy and currency of the documents, they are reviewed annually for statement of fact changes and must undergo a comprehensive review every 5 years.

State Hazard Plan – Hazardous Materials Emergencies (HAZMAT)

### STATE RECOVERY AMENDMENTS

The state-level recovery arrangements in the State Emergency Management Framework (EM Framework) are currently under review. The proposed amendments to the arrangements are:

- Proposed four-level State Model for Recovery Governance (R1-R4), which was trialled in the 23-24 high threat period. The Model defines increasing State involvement relative to the complexity of recovery and capacity of the local government.
- Clarification of roles and responsibilities for the state at various recovery levels, including the role of the State Recovery Coordinator, Event Recovery Coordinator (R3 State Led), and Event Recovery Controller (R4 State Controlled).
- A draft Assessment Support Tool to be utilised in assisting decision makers to assess the level of recovery under the proposed new State Model, including escalation / de-escalation of State involvement in recovery.

There will be a public consultation process on proposed changes to state-level recovery arrangements in the EM Framework. Recommendations for amendments to the EM Framework will be presented to SEMC for consideration.

### **SEMC STRATEGIC PLAN**

With the expiry of the current Strategic Plan in 2025, the SEMC reviewed its strategic direction in anticipation of the development of a new Strategic Plan. At a Strategic Planning workshop, the SEMC explored five key emergency management systemic issues:

- More frequent and severe emergencies;
- Consideration of a systemic approach to risk management;
- A whole of sector approach;
- Strengthening capability and capacity; and
- A focus on vulnerability, preparedness, and resilience.

Consultation on a new Strategic Plan, and the outcomes of the Strategic Planning workshop, will now occur with Subcommittees and District Emergency Management Committees throughout July, August and September 2024.

### **DISTRICT NEWS**

The District Emergency Management Committee (DEMC) was held on Tuesday 19<sup>th</sup> March 2024. The next meeting is scheduled for October 2024.

### **SECTOR UPDATES**

Australian Warning System (AWS) Training

The Australian Warning System (AWS) is a national approach to emergency information that delivers consistent warnings to Australian communities, so people know what they need to do to stay safe in an emergency, no matter where they are.

The AWS features standardised hazard warning icons and colours, with warnings supported by clear action statements.

Changes to cyclone, flood, storm and bushfire warnings was rolled out in Western Australia on Monday 15<sup>th</sup> July, 2024.

### Discussion:

Mrs Erin Hutchins advised that AWS Awareness is an online module available on the DFES Mobilise Me platform - https://dfes.mobilise-me.com and provides an overview of the Australian Warning System and how it is applied in Western Australia. Delivered as a self-paced, e-learning awareness module, this course is recommended for anyone wanting to gain a better understanding of the AWS. Course duration is approximately 15-20 minutes.

If users have previously undertaken training on the DFES Mobilise Me platform, they can use their credentials to log in and find the AWS courses.

For new users, they will need to create an account and select Australian Warning System under the "Learning Category" when they are registering their details.

### 8.2.3 Department of Fire & Emergency Services – Mr Brian Penman

### **WINTER SEASON 2024**

It was an early and busy start to the winter season with two major storm events impacting Bunbury on 10<sup>th</sup> May and 1<sup>st</sup> June 2024. Recovery activities continue for these events and Post Operational Reviews are planned. Call outs continue for local SES for maintenance of temporary repairs from these events. The DFES region has also noticed this season that rental property managers are referring their clients to the SES rather than arranging for contractors to make repairs, which is unnecessarily impacting the lives of Volunteers.

### Discussion:

Mr Penman advised that after the storms there were a lot of Rental Property Managers referring people to contact SES for damages incurred to their properties. Mr Penman has asked if we are in contact with anyone in relation to this can we please ask them to be getting in touch with the specialised contractors in those fields as the SES can no longer take on any more works.

### CLIMATE OUTLOOK (issued 18th July 2024)

The long-range forecast for August to October shows:

- Rainfall is likely to be within the typical seasonal range for much of southern WA.
- Warmer than average days and nights are likely to very likely across most of Australia, however, it is the cool season and periods of unusually cold weather are still possible.

The current pattern of warmth in global sea surface temperatures is unlike historical patterns. This is likely to impact the ability to predict the development of climate influences such as ENSO and IOD based solely on historic relationships between sea surface temperatures and these events.

### **AUSTRALIAN WARNING SYSTEM (AWS)**

Western Australia has adopted a national consistent approach to emergency information by using a standardised set of warning levels, colours and icons, supported by clear action statements to keep people safe.

Cyclone, storm and flood warnings join bushfire and heatwave in using AWS colours, icons and warning levels of Advice, Watch and Act and Emergency Warning. How you receive warnings may not change, but the wording, colours and call to action may be different to what you're used to, as this system is implemented across Australia.

The AWS has been designed based on feedback and research across the country and aims to deliver a more consistent approach to these types of emergencies, no matter where you are.

Australia's fire and emergency services aim to provide you with timely and relevant information during emergencies. Refer to https://www.australianwarningsystem.com.au for more information regarding the AWS.

### Discussion:

There is training available for staff and officers, which Mr Penman recommends officer to complete. The training can be done online via the below method.

AWS Awareness is an online module available on the DFES Mobilise Me platform - https://dfes.mobilise-me.com and provides an overview of the Australian Warning System and how it is applied in Western Australia. Delivered as a self-paced, e-learning awareness module, this course is recommended for anyone wanting to gain a better understanding of the AWS. Course duration is approximately 15-20 minutes.

If users have previously undertaken training on the DFES Mobilise Me platform, they can use their credentials to log in and find the AWS courses.

For new users, they will need to create an account and select Australian Warning System under the "Learning Category" when they are registering their details.

### Communities 2023/24 Statewide High Threat Season Activations

The Department of Communities' Emergency Relief and Support (ERS) Directorate would like to acknowledge and thank all of our local and state partners for the assistance and support provided over the 2023-24 season.

Since October 2023, there has been a total of fifty-one events supported by Communities statewide including:

- Activation under the AUSRECEPLAN

   Israel and Gaza repatriation.
- Pre-planning undertaken for 3 high threat weather events, which did not result in activation.
- A total of 496 people were supported during events through our client management system.
- Two Active and Declared Recovery Events (under Disaster Recovery Funding Arrangements) -Mariginiup Fire, Bunbury Storm.
- Just prior to Christmas 2023, there were 6 activations supported by Communities over just 2 days (20-22 December).

Our team looks forward to working with you all over the coming months as we prepare for the 2024-25 Season.

### **Communities Recovery Activities**

### **Kimberley Floods Recovery Program**

- The Kimberley Flood Recovery Team continues to support impacted residents, through the Hub.
- In addition to supporting impacted residents with their claims and eligibility requirements, this also extends to practical, personal and wellbeing supports.
- At present there are five projects supporting Fitzroy Valley individuals and communities, in varying capacities, and we are reviewing the scope for future project requirements.
- We are currently working with the Housing Team and the Hub to ensure residents understand their rights and obligations as they begin their journey from their temporary accommodation units to their home.

### **Mariginiup Fires Recovery Program**

Communities has supported the City of Wanneroo to deliver the psychosocial wellbeing and financial support elements of the recovery program for the fire affected community, with the final date of program delivery finishing on 30<sup>th</sup> June 2024.

### **Bunbury Storms Recovery Program**

A total of 42 displaced individuals were supported in temporary accommodation, of which 6 are still being supported as of 5<sup>th</sup> August. To date, Communities:

- Provided assistance with accommodation, food, clothing and personal requisites to displaced and impacted individuals.
- Supported individuals who have returned or are transitioning home with prepaid cards as well as food boxes as part of their Return Home packages.
- Are supporting individuals to access psychological supports via approved local providers.
- Have commenced a targeted outreach of known impacted people for Category 3 and 4 financial assistance.
- Is working with the Lions Club who are in the process of making up hampers to further support these individuals in their return home journey.
- Disaster Response Hotline remains open to provide support, with officers continuing to engage with impacted persons since the Recovery Hubs closed.
- Is finalising a procurement process with Red Cross for delivery of a recovery training program to the city.
- Continues to work closely with CoBunbury, DFES, local support agencies including property and strata management, Red Cross, Salvation Army, SWCLS, RAC, Foodbank and accommodation providers to ensure individual needs are met.

### **Local EM Information**

### **Emergency Evacuation Centre Training**

- The emergency evacuation centre training is being enhanced and revised to boost the knowledge and confidence of Communities district teams, local government and other partnering agencies to work within an emergency evacuation centre.
- This dynamic, interactive three-hour training enables participants to design and set up an evacuation centre, while navigating a variety of scenarios staff may encounter in such settings.
- Participants will include a cross section of Communities staff and local government agencies to foster collaboration and relationship building.
- Whenever possible, training will be held in designated evacuation centres to provide hands-on experience.

The ERS team will be in contact to arrange a training schedule and identifying dates and locations, Planning and Preparedness

The ERS Directorate are keen to work with Local Governments and partners in preparations and exercising. If you are running any exercises or events that would be of value and appropriate for ERS to attend, please let your ERS Regional Coordinator know.

The ERS Directorate can support the local government by reviewing your emergency kits ensuring that appropriate items and resources are available.

### **Activations**

- SoDardanup Eaton Bushfire (21st to 22nd December 2023) Evacuation Centre opened at Eaton Recreation Centre then moved to Eaton Boomers Football Club.
- SoCollie Coolongatta Bushfire (11th to 12th January 2024) Evacuation Centre opened at Roche Park.
- SoNannup Jalbarragup Millbrook State Forest Bushfire (17th to 18th January 2024) Evacuation Centre opened at Nannup Recreation Centre.
- SoHarvey Leschenault and Australind Bushfire (27th February 2024) Evacuation Centre opened at Eaton Recreation Centre.
- SoCapel Harewoods Bushfire (10th March to 11th March 2024) South West Sports Centre.
- SoManjimup Walpole Middle Road Complex Bushfire (26th to 27th April 2024) Evacuation Centre opened at Walpole Recreation Centre.
- CoBunbury Bunbury Tornado (10th May 2024 ongoing) Evacuation Centre opened at Eaton Recreation Centre.
- CoBunbury Bunbury Storm (1st June 2024 ongoing) Evacuation Centre opened at South West Sports Centre

### Discussion:

A Border update was given in relation to the current outbreak of Polyphargus and Mr Tim Stevens advised the following.

The WA Department of Primary Industries and Regional Development (DPIRD) leads the response to this outbreak.

A \$41.29 million Response Plan has been approved and aims to eradicate Polyphagous shot-hole borer. It covers all aspects of the response including:

- monitoring and early detection
- an extensive media campaign
- a surveillance and trapping program across the QA and broader Perth region
- destruction of infested material, with plant material double chipped and heat composted
- eradication and freedom activities until June 2025.

The plan was endorsed through the national emergency plant pest response arrangement. Costs are shared by the Australian and state and territory governments. The WA government contributes extra resources and funding to the eradication program.

You must report immediately if you:

• live in WA and have a box elder maple tree (on your property or street. The WA government will check it for infestation by the borer.

• see signs of the polyphagous shot-hole borer in trees or plant material. Keep the material on your property.

If you suspect a pest or disease outbreak, report it. Even if you're not sure.
